Larson called the meeting to order at 8:30 a.m. at the Iowa Medicaid Enterprise. Commission members, guests, and observers were welcomed and introduced.

Larson provided an overview of the problems that developed for the pediatric and adolescent psychiatrists within the state when quantity limits were placed on October 28, 2007. Quantity limits on 9 drugs were rescinded on November 28, 2007.

The Mental Health Work Group (MHWG) discussed quantity limit edits for Abilify and Risperdal and their impact on the psychiatrists within the state. The MHWG agreed on the list of edits on the following page and these will be referred to the Iowa Medicaid Drug Utilization Review Commission for their approval. In addition, a letter regarding these edits will be forwarded to the Iowa Psychiatric Society for dissemination to its members for comments.
